INTRODUCTION TO CAREGIVING AND UNDERSTANDING THE HEALTHCARE INDUSTRY

In addition, to understand the primary goal as a caregiver to provide quality patient care, while strongly advocating patient's individualized needs.

BECOMING A 'CAREGIVER' AND UNDERSTANDING EFFECTIVE SKILLS IN THE HEALTHCARE INDUSTRY

The aim of this unit is to introduce learners to becoming a caregiver and helping them through the journey with skills, including technical skills – the knowledge needed to perform specific tasks, and soft skills – the way to interact with people and solve problems.

PROVIDING CARE FOR INFANT, TODDLER AND CHILDREN IN THE HEALTHCARE INDUSTRY

The aim of this unit is to introduce learners to : The theory underpinning growth and development in childhood and ; The role of the children's caregiver while communicating with infants, toddlers and children.

PROVIDING CARE FOR AGING POPULATION IN THE HEALTHCARE INDUSTRY

The aim of this unit is to introduce learners to the theories and functions of caregivers working with the aging population. To provide effective community care through the introduction of appropriate exercises and healthy behaviours for seniors to enhance their physical health, emotional and mental resilience, and social activeness.

COMMON ILLNESSES AND INFECTIONS AMONG AGING POPULATION IN THE HEALTHCARE INDUSTRY

The aim of this module is to equip learners with knowledge of common illnesses, infections and control. Understanding common illnesses among the aging generation and caregivers' responsibilities of accountability to implement and monitor infection control and procedures that are appropriately adapted.

MODULES DESCRIPTION

NURSING HOME AND PALLIATIVE OR HOSPICE CARE IN THE HEALTHCARE INDUSTRY

The aim of this module is to provide learners with a broad introduction to residential care for patients in the industry. These facilities will provide short-term or long-term care with assistance to residents who need help in most of their activities of daily living and/or have daily nursing care needs. Palliative and hospice care provides specialized medical care for people living with a serious illness.

EXERCISE AND NUTRITIONAL INTERVENTIONS FOR OLDER ADULTS

The aim of this unit is to introduce learners to : The physiological changes of aging and its implications on the function of the human body ; Create personalized training programs to improve functionality in older adults and ; Evaluate suitable nutritional interventions for various chronic conditions and diseases.

STANDARD FIRST AID AND CARE

The aim of this unit is to introduce learners to : Identify the underlying causes of different types of injuries ; Administer basic immediate first aid without any medical help ; Perform adult CPR and use the AED and ; Learn foreign body airway obstruction (i.e. choking) management for a conscious or unconscious adult.

CAPSTONE PROJECT

This unit is the final project where learners have hands-on experience to design and implement a care plan for a patient / client. During this unit, the learner will also be expected to undertake real-life observation of how a professional care giver executes the care plan for said patient / client. This will culminate in the preparation of an observation report where the learner will be expected to present his/her findings during the observation, and the adequacy of his/her care plan.
